AND WHEREAS with a view to and for the purpose of constituting the trust permanently for the purpose of carrying on the objectives of the trust as mentioned hereafter under the aims and objects clause of this deed of trust. It is considered desirable that for the purpose of creation of the trust the declaration of the trust should be made in the manner set out hereunder.

NOW THIS INDENTURE WITNESSETH as follows:

2. INTERPRETATION

- (a) TRUST (Trust) means the trust created by this deed viz.
- (b) BALIPUKUR MINORITY EDUCATIONAL AND HEALTH WELFARE TRUST.
- (c) The BOARD shall mean the Board of trustees created by this deed.
- (d) The Trust Property shall include every kind of property movable and immovable, owned by the trust and mentioned in accounts, books and other documents in the possession, custody control of the trust.

3. AIMS AND OBJECTS OF THE TRUST

- (a) To promote the educational, social and economic, health upliftment and general welfare of the citizen of India, the people belonging to minority, backward community and others community.
- (b) To support and grant aid, other financial assistance to educational institutions.
- (c) To take over, establish, acquire, start, run, maintain or manage educational institutions, hospital, library, study centre.
- (d) To award scholarship for the deserving student for technical, medical, professional and general studies.
- (e) To encourage athletic activities of youths and students and to conduct educational tours, sports, games, tournaments for them.
- (f) To establish and run hostels for students for all community girls and boys students.
- (g) To organize relief work in the event of natural calamities, riots and social upheavals in any part of the country.
- (h) To create and accept donations, subscriptions, charges, fees, gifts, benefactor, bequeath and grants in cash or kind from public institutions,

Government, Semi Government from inside the country and from abroad for achieving the object of the trust.

- (i) To associate, co-operate and collaborate with and assist any others societies having similar aims and objects.
- (j) To distribute books to the deserving students in the name of the trust in each and every year when the academic session shall commence.
- (k) To establish charitable health centre and hospital for the medical treatment of the poor people of the locality and do everything for the said purpose.
- (l) To do all such things as the trustees will deem fit, necessary incidental or conducive to the dictates or basic teachings of the substance for the attainment or any of the objects of the trust.

4. RAISING OF FUND AND EXPENDITURE

AND for achieving any of all the objects of the Trust of Trustees can raise funds through donations, grants and contributions and to obtain and receive interest free loans from individuals, associations, firms or any institution whatsoever and to invest and deal with the money and funds belonging to the Trust not immediately required to such manner as may from time to time be determined by the Board of the Trustees subject to the law of the land, and to take on lease or purchase or accept by way of gift any land, building or any other property both movable and immovable and to remunerate any person, firm or institution for services rendered to the Trust in any capacity and to pay to any out of the funds of the Trust all costs, charges expenses incidental to the establishment, registration and advertisements of this Trust and to adopt and take such other lawful means as may be incidental and conducive to the accomplishments of all or any of the above objects and shall also receive grants and donations from Foreign Governments, Institutions or Agencies and Individuals according to the prevailing law of the land.

The income and properties of the Trust Whatsoever derived or obtained shall be applied solely towards the promotion of the objects of the Trust and no portion thereof shall be paid to or divided amongst any of its members by way of profits.

5. ADMINISTRATION:

The properties and funds shall vest in the Board of Trustees constituted by persons mentioned in this Deed of Trust. The number of members of Board of Trustees shall not exceed 25 (twenty five) and if there are vacancies after the execution of this Deed the same can be filled by co-operation by the Board of Trustees.

6. OFFICE BEARERS OF THE TRUST BOARD

Office bearers of the Trust Board shall be as follows:

- i. President – 1
- ii. Vice-President – 2.
- iii. Secretary – 1
- iv. Asst. Secretary – 1
- v. Treasurer 1 and Patron – 1
- vi. Rest 19 others as members.

The Board of Trustees is also authorized to create any other post of office bearers and elect other office bearers to fill up the post from among the Trustees. The above office bearers shall be elected from among themselves by a majority of the trustees at a meeting convened for the purpose. The Board is also authorized to co-opt. trustee members and to increase the number to trustee member for the benefit and smooth sunning of the function of the trust in an meeting adopting an unanimous regulations of the Board of Trustee.

7. QUORUM

2/3 members present and voting shall be the quorum for any meeting.

8. VACANCIES:

Any vacancy shall arise among the Trustees in the following cases:

- i. When a Trustee dies;
- ii. When he resigns his office as Trustees;
- iii. When he is absent from three consecutive meetings of the Board, unless the Board records condoning such absence in the minute of the meetings of the Board of Trustees for substantial causes;
- iv. When he becomes insolvent;
- v. When he is convicted of any criminal offence involving moral turpitude;
- vi. When he acts or does anything detrimental to the interests of the Trust;
- vii. On medical evidence when he is declared physically or mentally unfit by resolution of the Board at a meeting convened for the purpose.

In case of any vacancy arising among the Trustees new Trustees shall be nominated or appointed and such persons shall be of sound mind, who shall be above eighteen years of age and who shall subscribe to the objects of the Trust.

The Board of Trustees by a 2/3rd majority or existing members attending the meeting convened for the purpose, shall fill up the vacancies arising in the Board of Trustees.

9. TERM OF OFFICE:

The "Settler Trustee" in consultation with other life trustee's members shall select the member of trustees who have been interest to social work, having clean image and faith on the aims and objects of this trust. The Board of Trustees shall elect the office bearers, from among themselves within a month of the formation of the Trust. They shall remain in office for 5 (five) years. Prior to expiry of term, the Board of trustees shall elect new office bearers prior to one month of expiry of terms and no and from the expiry of terms of outgoing office bearers, the new elected officer bearers shall resume power and the makeover and takeover of charge shall be made on the date on expiry of settler trustee, the Chairman shall have power to select trustee members.

10. POWER OF TRUSTEES:

The board of Trustees shall have the following powers:

- (a) To call for and collect and receive funds collectively or individually and such funds may be utilized by them for such purposes and objects of the Trust as they deem fit.
- (b) To take part and receive contributions on behalf of the TRUST.
- (c) To accept and receive contributions on behalf of the TRUST.
- (d) To acquire movable and immovable property by purchase or otherwise.
- (e) To create or cause to be created building or buildings, equipments and machinery for the use, benefit and attainment of the objects of TRUST.
- (f) To sell, transfer, exchange and immovable properties belonging to the TRUST.
- (g) To manage, administer and control properties and all assets of the Trust directly or indirectly and all institutions under or connected with the TRUST.

- (h) To demand, call for the realized money and other assets due or belonging to the TRUST and issue receipts and vouchers for the receipt of the same.
- (i) To employ necessary staff for the management, administration and running of the TRUST in general and for the institutions in particular and for the purpose of carrying out the object of the TRUST, and such terms as may appear proper to the TRUSTEES and to delegate and to allot to such staff from time to time, such powers and duties as may be necessary in the usual course of business.
- (j) To appoint from time to time and at any time to suspend, dismiss, remove or discharge and any person under their control including clerks, accountant and to re-employ them with such powers and duties and upon such terms either by giving one month notice or by giving one month salary as the Board of Trustees shall think proper.
- (k) The board shall have full powers to make, amend, delete or rescind rules and bye-rules of the TRUST.
- (l) To do all acts things which are connected with the administration of the Trust in general and of the institutions in particular and which are deemed by the Trustees to be in the best interest of the Trust and are desirable.

11. FUNCTIONS OF THE OFFICE BEARERS:

11.2. VICE PRESIDENT:

11.3. SECRETARY:

16. BOARD MEETINGS:

- (a) A meeting of the Board shall be held ordinarily at least once in six months or earlier on the requisition or the least 1/3rd or the Trustees to consider the affairs of the Trust and all the proceedings of the meeting shall be recorded in the minute book to be preserved by the Secretary on behalf of the Trust.
